Available through the Live Trainings by Request and Virtual Trainings by Request programs, this training presents information on how institutions of higher education (IHEs) can collaborate with their local government and community partners to plan for potential emergencies through the creation of a high-quality higher ed emergency operations plan (EOP). For each training modality, the REMS TA Center will provide — free of charge — training materials, as well as one or more live subject matter expert trainers and staff support for the event hosted at your site or online.

Learn key considerations for creating, revising, or enhancing higher ed EOPs using the recommended six-step planning process, outlined in the *Guide for Developing High-Quality Emergency Operations*Plans for Institutions of Higher Education. The training is designed to help IHEs develop a custom plan that addresses a range of hazards and threats, conduct a comprehensive review of their entire plan, or conduct periodic and incremental reviews of a plan's components. The planning process discussed during the training is flexible and can be adapted to accommodate an IHE's unique characteristics and situation. Below, you will find information about each synchronous training format.

IHE 101 Train-the-Educator (TtE)

This half-day training presents important Federal guidance on higher ed emergency management planning. It provides an overview of the recommended six-step planning process to create a high-quality higher ed EOP.

WHO SHOULD ATTEND

- ✓ IHE administrators, faculty, and staff;
- ✓ Members of an IHE planning team;
- ✓ Campus public safety officials;
- ✓ Students;

APPIY

- ✓ Individuals who have a role or responsibility in campus safety, security, and emergency preparedness; and
- Community partners.

IHE 101 Train-the-Trainer (TtT)

This full-day training follows a format similar to that of the Train-the-Educator but goes further into the six-step planning process recommended for creating a high-quality EOP. It is intended to build the capacity of your institution by creating a cadre of master trainers to deliver future trainings.

WHO SHOULD ATTEND

- ✔ Potential master trainers from participating IHEs responsible for training site-based planning teams; and
- ✓ The same audience as for the TtE.
